Normally, the Fund invests the majority of its total assets in companies that pay dividends or repurchase their shares.

Market commentary

Equity prices continued to decline in the second quarter as accelerated central bank tightening and recession fears weighed on the outlook for economic growth. The top performing markets in our investable universe were China, Hong Kong, the Czech Republic, Portugal, and Kuwait. The worst performing markets were Peru, Colombia, Poland, Hungary, and Brazil. The best performing sectors in the MSCI ACWI Index ("Index") were energy, consumer staples, and utilities. The worst performing sectors were information technology, consumer discretionary, and materials. Currency proved a headwind as major currencies declined against the US dollar.

The Causeway Global Value Fund ("Fund") outperformed the Index during the quarter, due primarily to stock selection. Fund holdings in the banks and materials industry groups, as well as an underweight position in the energy, semiconductors & semi equipment, and retailing industry groups, contributed to relative performance. Holdings in the capital goods, media & entertainment, and utilities industry groups, along with an underweight position in the telecommunication services and food beverage & tobacco industry groups, offset some of the outperformance compared to the Index. The top contributor to return was integrated oil & gas company, TotalEnergies SE (France). Other notable contributors included pharmaceutical giant, Sanofi (France), financial services provider, ING Groep NV (Netherlands), financial services provider, Credit Suisse Group AG (Switzerland), and AIR Liquide (France). The largest detractor was travel & tourism technology company, Sabre Corp. (United States). Additional notable detractors included jet engine manufacturer, Rolls-Royce Holdings Plc (United Kingdom), media & entertainment conglomerate, The Walt Disney Co. (United States), electronic equipment manufacturer, Samsung Electronics Co., Ltd. (South Korea), and online travel agency, Booking Holdings, Inc. (United States).
