Investment objective

The Fund invests primarily in common stocks of companies in developed countries outside the United States and of companies in the United States. Normally, the Fund invests the majority of its total assets in companies that pay dividends or repurchase their shares.

Effective October 1, 2018, the Global Value Fund's benchmark changed from the MSCI World Index (Gross) to the MSCI ACWI Index (Gross). Causeway believes that the MSCI ACWI Index (Gross), which includes emerging as well as developed markets, better represents the types of securities in which the strategy invests. The MSCI ACWI Index (Gross) is a free float-adjusted market capitalization index, designed to measure the equity market performance of developed and emerging markets, consisting of 23 developed country indices, including the U.S., and 24 emerging market country indices. Prior to October 1, 2018, the benchmark index for the Global Value Fund was the MSCI World Index (Gross). This Index is a free float adjusted market capitalization weighted index, designed to measure developed market equity performance, consisting of 23 developed country indices, including the U.S. The Indices are gross of withholding taxes, assume reinvestment of dividends and capital gains, and assume no management, custody, transaction or other expenses. It is not possible to invest directly in an index.

Market commentary

Heightened geopolitical tensions and concerns of a broader slowdown in global economic growth pressured equity markets in the fourth quarter. The top performing markets in our investable universe were Brazil, Indonesia, Qatar, Hungary, and the Philippines. The worst performing markets were Pakistan, Austria, Colombia, Mexico, and Belgium. The best performing sectors in the MSCI ACWI Index ("Index") were utilities, real estate, and communication services. The worst performing sectors were energy, information technology, and industrials.

The Causeway Global Value Fund ("Fund") underperformed the Index during the quarter, due primarily to stock selection. Attractive valuations did not provide immunity from the selling, especially in non-US equity markets. Fund holdings in the banks, energy, media & entertainment, insurance, and food beverage & tobacco industry groups detracted from relative performance. Holdings in the materials, transportation, and pharmaceuticals & biotechnology industry groups, as well as an overweight position in the telecommunication services industry group and an underweight position in the technology hardware & equipment industry group, offset some of the underperformance. The largest detractor was energy exploration & production company, Halliburton Co. (United States). Additional notable detractors included specialty retail jeweler, Signet Group (United States), British American Tobacco plc (United Kingdom), global financial services giant, Citigroup, Inc. (United States), and banking & financial services company, UniCredit S.p.A. (Italy). The top contributor to return was industrial gas company, Linde Plc (Germany). Other notable contributors included electric & natural gas utility, Dominion Energy, Inc. (United States), integrated utility, FirstEnergy Corp. (United States), retail & commercial bank, Akbank TAS (Turkey), and design-to-distribution business process services technology company, SYNnex Corp. (United States).
