Investment objective

Causeway Concentrated Equity Fund seeks long-term growth of capital.

The Fund invests at least 80% of its total assets in equity securities of companies in the U.S and in developed and emerging countries outside the U.S. The Fund will typically hold between 25 and 35 investments. Equity securities include common stock, preferred and preference stock, and depositary receipts.

Market commentary

Equities finished the third quarter relatively flat, as a pullback in share prices in September offset earlier gains in July and August. The decline comes amid concerns over a moderation in economic growth rates, supply chain disruptions, and rising inflation. The top performing markets in our investable universe were Argentina, the Czech Republic, India, Austria, and Colombia. The worst performing markets were Brazil, China, Pakistan, South Korea, and Peru. The best performing sectors in the MSCI ACWI Index ("Index") were energy, financials, and information technology. The worst performing sectors were consumer discretionary, materials, and communication services.

The Causeway Concentrated Equity Fund ("Fund") outperformed the Index during the quarter, due primarily to stock selection. Fund holdings in the capital goods, health care equipment & services, software & services, and media & entertainment industry groups, as well as an underweight position in the retailing industry group, contributed to relative performance. Holdings in the consumer services, pharmaceuticals & biotechnology, and technology hardware & equipment industry groups, along with an underweight position in the energy and diversified financials industry groups, offset some of the outperformance compared to the Index. The top contributor to return was jet engine manufacturer, Rolls-Royce Holdings Plc (United Kingdom). Other notable contributors included medical technology provider, Hill-Rom Holdings (United States), enterprise management software provider, Oracle Corp. (United States), utilities provider, Exelon Corp. (United States), and insurer, AXA SA (France). The largest detractor was casino & resort company, Las Vegas Sands Corp. (United States). Additional notable detractors included electronic equipment manufacturer, Samsung Electronics Co., Ltd. (South Korea), pharmaceutical giant, Sanofi (France), pharmaceutical producer, Novartis AG (Switzerland), and electric, gas & renewables power generation & distribution company, Enel SpA (Italy).
