Investment objective

The Fund's investment objective is to seek long-term growth of capital and income.

The Fund invests primarily in common stocks of companies in developed countries outside the United States. Normally, the Fund invests at least 80% of its total assets in stocks of companies in a number of foreign countries, and invests the majority of its total assets in companies that pay dividends or repurchase their shares.

Market commentary

Bolstered by optimism for an end to the COVID-19 pandemic as several countries began rolling out vaccines, global equity markets rose in the fourth quarter to close out the year. The top performing markets in our investable universe were Austria, South Korea, Mexico, Spain, and Australia. The worst performing markets were Switzerland, Finland, China, Germany, and Ireland. The best performing sectors in the MSCI EAFE Index ("Index") were energy, financials, and consumer discretionary. The worst performing sectors were health care, consumer staples, and utilities. Currency proved favorable as major currencies advanced against the US dollar.

The Causeway International Value Fund ("Fund") outperformed the Index during the quarter, due primarily to stock selection. Fund holdings in the capital goods, transportation, technology hardware & equipment, and media & entertainment industry groups, as well as an overweight position in the banks industry group, contributed to relative performance. Holdings in the energy and food & staples retailing industry groups, along with an overweight position in the pharmaceuticals & biotechnology industry group and an underweight position in the diversified financials and telecommunication services industry groups, offset some of the outperformance compared to the Index. The top contributor to return was jet engine manufacturer, Rolls-Royce Holdings Plc (United Kingdom). Other notable contributors included electronic equipment manufacturer, Samsung Electronics Co., Ltd. (South Korea), bank, Banco Bilbao Vizcaya Argentaria SA (Spain), banking & financial services company, Barclays Plc (United Kingdom), and financial services provider, ING Groep NV (Netherlands). The largest detractor was business software & services provider, SAP SE (Germany). Additional notable detractors included pharmaceuticals & chemicals company, Bayer AG (Germany), pharmaceutical giant, Sanofi (France), energy technology company, Siemens Energy AG (Germany), and beverage bottler, Coca-Cola European Partners Plc (United Kingdom).
