The Fund invests primarily in common stocks of companies in developed countries outside the United States and of companies in the United States. Normally, the Fund invests the majority of its total assets in companies that pay dividends or repurchase their shares.

Market commentary

Global equities rallied in the fourth quarter, capping off the third consecutive calendar year of strong positive returns. The top performing markets in our investable universe were Egypt, Switzerland, the Czech Republic, Peru, and the United Arab Emirates. The worst performing markets were Turkey, Hungary, Chile, Russia, and Argentina. The best performing sectors in the MSCI ACWI Index ("Index") were information technology, utilities, and real estate. The worst performing sectors were communication services, energy, and financials.

The Causeway Global Value Fund ("Fund") underperformed the Index during the quarter, due primarily to stock selection. Fund holdings in the capital goods, software & services, technology hardware & equipment, transportation, and pharmaceuticals & biotechnology industry groups detracted from relative performance. Holdings in the consumer durables & apparel, banks, semiconductors & semi equipment, and media & entertainment industry groups, as well as an underweight position in the telecommunication services industry group, offset some of the underperformance compared to the Index. The largest detractor was travel & tourism technology company, Sabre Corp. (United States). Additional notable detractors included jet engine manufacturer, Rolls-Royce Holdings Plc (United Kingdom), Takeda Pharmaceutical Co., Ltd. (Japan), power & healthcare conglomerate, General Electric Co. (United States), and paper & packaging solutions company, WestRock Co. (United States). The top contributor to return was semiconductor manufacturer, Broadcom Corp. (United States). Other notable contributors included luxury goods manufacturer & retailer, Compagnie Financière Richemont SA (Switzerland), banking & financial services company, UniCredit S.p.A. (Italy), specialty chemicals manufacturer, Ashland Global Holdings, Inc. (United States), and plastic packaging manufacturer, Berry Global Group (United States).
