The Fund invests primarily in common stocks of companies in developed countries outside the United States. Normally, the Fund invests at least 80% of its total assets in stocks of companies in a number of foreign countries, and invests the majority of its total assets in companies that pay dividends or repurchase their shares.

**Market commentary**

Global equities rallied in the fourth quarter, capping off the third consecutive calendar year of strong positive returns. The top performing markets in our investable universe were Switzerland, Peru, Canada, Israel, and France. The worst performing markets were China, Japan, New Zealand, Hong Kong, and Singapore. The best performing sectors in the MSCI EAFE Index ("Index") were utilities, materials, and consumer staples. The worst performing sectors were communication services, energy, and real estate. Every major currency except the Japanese yen and euro appreciated versus the US dollar during the period, thus amplifying overall returns on overseas assets for US dollar-based investors.

The Causeway International Value Fund ("Fund") underperformed the Index during the quarter, due primarily to stock selection. Fund holdings in the capital goods, materials, pharmaceuticals & biotechnology, transportation, and food beverage & tobacco industry groups detracted from relative performance. Holdings in the consumer services, banks, and software & services industry groups, as well as an underweight position in the telecommunication services and media & entertainment industry groups, offset some of the underperformance compared to the Index. The largest detractor was jet engine manufacturer, Rolls-Royce Holdings Plc (United Kingdom). Additional notable detractors included Takeda Pharmaceutical Co., Ltd. (Japan), electronic components manufacturer, Murata Manufacturing Co. Ltd. (Japan), retail bank, CaixaBank SA (Spain), and diversified chemicals manufacturer, BASF SE (Germany). The top contributor to return was banking & financial services company, UniCredit S.p.A. (Italy). Other notable contributors included luxury goods manufacturer & retailer, Compagnie Financière Richemont SA (Switzerland), products & services provider for the electronic components industry, SK hynix, Inc. (South Korea), pharmaceuticals & biotechnology company, Roche Holding AG (Switzerland), and electric utility provider, RWE AG (Germany).
