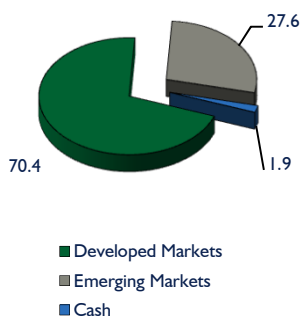

## Investment objective

The Fund's investment objective is to seek long-term growth of capital.

The Fund invests primarily in companies both in developed markets - excluding the United States ("international value portfolio") - and in emerging markets ("emerging markets portfolio"). The Investment Adviser allocates substantially all of the Fund's assets between the international value portfolio and the emerging markets portfolio using a proprietary asset allocation model.

## Fund features

- The international value portfolio uses bottom-up stock selection based on fundamental research, focusing on mid to large cap value stocks in developed international markets.
- The emerging markets portfolio uses an actively managed tracking-error oriented quantitative strategy, combining bottom-up and top-down factors in security selection.

## Market commentary

Global equities declined again in the third quarter as many central banks reiterated their commitment to fighting inflation. The top performing markets in our investable universe were Turkey, Brazil, Indonesia, India, and Chile. The worst performing markets were Poland, China, Colombia, the Czech Republic, and Hong Kong. The best performing sectors in the MSCI ACWI ex USA Index ("Index") were energy, consumer staples, and materials. The worst performing sectors were communication services, real estate, and consumer discretionary. Currency proved a headwind as major currencies declined against the US dollar.

The Causeway International Opportunities Fund ("Fund") underperformed the Index during the quarter, due primarily to stock selection. Fund holdings in the capital goods, pharmaceuticals & biotechnology, food beverage & tobacco, health care equipment & services, and software & services industry groups detracted from relative performance. Holdings in the banks and energy industry groups, as well as an underweight position in the real estate, media & entertainment, and telecommunication services industry groups, offset some of the underperformance compared to the Index. The largest detractor was jet engine manufacturer, Rolls-Royce Holdings Plc (United Kingdom). Additional notable detractors included electric, gas & renewables power generation & distribution company, Enel SpA (Italy), pharmaceutical giant, Sanofi (France), life insurer, Prudential Plc (United Kingdom), and rolling stock, signaling, & services provider for the rail industry, Alstom SA (France). The top contributor to return was banking & financial services company, UniCredit S.p.A. (Italy). Other notable contributors included oil & gas exploration company, Petróleo Brasileiro SA - ADR (Brazil), bank, ICICI Bank Ltd. - ADR (India), banking & financial services provider, Swedbank AB (Sweden), and bank, Banco do Brasil SA (Brazil).

## Equity allocation model update

We use a proprietary quantitative equity allocation model that assists the portfolio managers in determining the weight of emerging versus developed markets in the Fund. Our allocation relative to the weight of emerging markets in the Index is currently underweight. We identify five primary factors as most indicative of the ideal allocation target: valuation, quality, earnings growth, macroeconomic, and risk aversion. Valuation is currently neutral for emerging markets in our model. Our quality metrics, which include such measures as profit margins and return on equity, are negative. Our earnings growth factor is negative, and our macroeconomic factor is negative for emerging markets. Lastly, our risk aversion factor is positive in our model.
