The Fund's investment objective is to seek long-term growth of capital and income.

The Fund invests primarily in common stocks of companies in developed countries outside the United States. Normally, the Fund invests at least 80% of its total assets in stocks of companies in a number of foreign countries, and invests the majority of its total assets in companies that pay dividends or repurchase their shares.

Market commentary

Global equities declined again in the third quarter as many central banks reiterated their commitment to fighting inflation. The top performing markets in our investable universe were Singapore, Israel, Ireland, Australia, and Finland. The worst performing markets were China, Hong Kong, South Korea, Norway, and Austria. The best performing sectors in the MSCI EAFE Index ("Index") were energy, consumer staples, and information technology. The worst performing sectors were communication services, utilities, and real estate. Currency proved a headwind as major currencies declined against the US dollar.

The Causeway International Value Fund ("Fund") underperformed the Index during the quarter, due primarily to stock selection. Fund holdings in the capital goods, pharmaceuticals & biotechnology, technology hardware & equipment, software & services, and food beverage & tobacco industry groups detracted from relative performance. Holdings in the banks and consumer services industry groups, as well as an underweight position in the telecommunication services, real estate, and diversified financials industry groups, offset some of the underperformance compared to the Index. The largest detractor was jet engine manufacturer, Rolls-Royce Holdings Plc (United Kingdom). Additional notable detractors included electric, gas & renewables power generation & distribution company, Enel SpA (Italy), life insurer, Prudential Plc (United Kingdom), pharmaceutical giant, Sanofi (France), and rolling stock, signaling, & services provider for the rail industry, Alstom SA (France). The top contributor to return was banking & financial services company, UniCredit S.p.A. (Italy). Other notable contributors included integrated resort developer & operator, Sands China Ltd. (Hong Kong), banking & financial services provider, Swedbank AB (Sweden), industrial conglomerate, Siemens AG (Germany), and luxury goods manufacturer & retailer, Compagnie Financière Richemont SA (Switzerland).
