The Fund invests primarily in common stocks of companies in developed countries outside the United States. Normally, the Fund invests at least 80% of its total assets in stocks of companies in a number of foreign countries, and invests the majority of its total assets in companies that pay dividends or repurchase their shares.

Market commentary

International equity markets rose sharply in the fourth quarter, on easing inflation concerns and optimism for China's continued reopening. Boosted by a weaker dollar, December's returns were positive, although comparatively modest, tempered by disappointing economic data and rising bond yields. The top performing markets in our investable universe were Denmark, Austria, and Italy. The worst performing markets were Israel, Canada, and Switzerland. The best performing sectors in the MSCI EAFE Index ("Index") were financials, materials, and energy. The worst performing sectors were communication services, consumer staples, and real estate. Currency proved favorable as major currencies advanced against the US dollar.

The Causeway International Value Fund ("Fund"), on a net asset value basis, outperformed the Index during the quarter. On a gross return basis, Fund holdings in the banks, capital goods, and insurance industry groups contributed to relative performance. Holdings in the semiconductors & semi equipment and household & personal products industry groups, along with an overweight position in the pharmaceuticals & biotechnology industry group, offset some of the outperformance compared to the Index. The top contributor to return was jet engine manufacturer, Rolls-Royce Holdings Plc (United Kingdom). Other notable contributors included banking & financial services company, UniCredit S.p.A. (Italy), and life insurer, Prudential Plc (United Kingdom). The largest detractor was pharmaceuticals & biotechnology company, Roche Holding AG (Switzerland). Additional notable detractors included bank, Banco Bradesco SA - ADR (Brazil), and civil construction company, Balfour Beatty Plc (United Kingdom).
