The Fund invests primarily in common stocks of companies in developed countries outside the United States. Normally, the Fund invests at least 80% of its total assets in stocks of companies in a number of foreign countries, and invests the majority of its total assets in companies that pay dividends or repurchase their shares.

Market commentary

Global equity markets rebounded in June to cap a strong first half of calendar year 2023. The best-performing sectors in the MSCI EAFE Index were consumer discretionary, materials, and industrials. The worst-performing sectors were health care, real estate, and communication services. The top-performing markets in our investable universe were Peru, Italy, and Austria. The worst-performing markets were Finland, South Korea, and Singapore.

The Causeway International Value Fund ("Fund"), on a net asset value basis, outperformed the Index during the quarter, due primarily to stock selection. On a gross return basis, Fund holdings in the banks, materials, and health care equipment & services industry groups contributed to relative performance. Holdings in the capital goods and food beverage & tobacco industry groups, along with an underweight position in the automobiles & components industry group, offset some of the outperformance compared to the Index. The top contributor to return was banking & financial services company, UniCredit S.p.A. (Italy). Other notable contributors included electronic equipment manufacturer, Samsung Electronics Co., Ltd. (South Korea), and semiconductor company, SK hynix, Inc. (South Korea). The largest detractor was beverage company, Anheuser-Busch InBev SA/NV (Belgium). Additional notable detractors included communication services provider, Deutsche Telekom AG (Germany), and pharmaceuticals & chemicals company, Bayer AG (Germany).
